City Update: Laura Pearce

City is undergoing the ECDEV action plan strategy outlining scope of next 5 years. Once approved, Laura to share initiatives and tactics as it relates to the Hespeler BIA and core areas. Some of the motions that are currently pending:

- Downtown Cambridge BIA proposing an expansion. The process would be the same if Hespeler wanted to propose an expansion of the BIA.
- Permanent road closure on Main St. between Water and Ainslie. In November they'll consider 3 options.
- Hespeler Heritage Study has moved to the plan phase. Upcoming public information (PIC) open house on Dec 4 at 7pm at the Hespeler Legion. If anyone interested, contact Joanie Parsons (Laura can send her contact). Anticipated to go to council in april 2025
- Reminder to submit permit applications for hanging holiday decor.
- 50/50 funds need to be spent by Dec 31.
- The City undertaking a comprehensive review of all 3 BIAs of relationship with the city. Report coming to council sometime in Nov.
- Laura attended an Ontario Association BIA event. She plans to share some highlights and takeaways next month.

Music & Lights in the Village

Other Updates

Garbage collection

Concerns were raised about garbage collection during summer street closure. Changed from being at either end of the road closure to in front of their shop all year round. Hasn't heard of any issues with this pilot. City is undergoing a review for what garbage collection will be going forward. Region is proposing a change from bags to automated bin garbage collection. Region did approve an automated garbage bin collection going forward at a minimum of 4 days/wk. Approved last month or August and we've been advised that the Region's staff will connect with update BIAs and city staff on this. Concern noted for apartments and businesses downtown.

Explore WR membership and Halloween Hunt

Idea to offer some sort of incentive for the first 5 memberships being sent in. Include FAQs - does it cost anything, will I be spammed, etc. The greater dense membership they have from Hespeler, the greater support they can justify - we want them to promote Hespeler so we need to show up as members.

BIA Christmas Lights

Nothing preventing BIA members from using BIA Christmas lights. We have extra lights we can lend members if they want to decorate their holiday windows. Snowflakes are still going up. Trees in the park are still being lit this year.

Music & Lights in the Village

Cory invited Tara to be our representative for Music & Lights in the Village again. She will decide on this.

Blooms of Paradise

Business owner indicated a concern for communication in the community about their intention for business. She's taking appropriate action and requests the BIA's support in the process, as needed. BIA will support in any way we can.

New Pet Store in Hespeler

Tim noted there's a new pet store opening across from the variety store (where the cannabis store was).

Question was raised about the status of the rental building on corner of Queen St. and Guelph Ave.
